



ENROLMENT TERMS & CONDITIONS

1. There is an annual, \$50 non-refundable enrolment fee payable on UNITY Dance Co's confirmation of the student's enrolment.
2. Please be aware classes are charged by the term, our term dates are set by Unity Dance Co each year. Classes do not operate on Public Holidays regardless of whether they fall within the term.
3. New students enrolling in UNITY Dance Co or existing students wishing to add additional classes mid-term will be invoiced for the balance of the current term when enrolment is confirmed.
4. All invoices are due and payable within 14 days of issue unless stated otherwise, a late payment fee may be applied to any amount outstanding after the invoice due date.
5. It is understood that there are NO REFUNDS on tuition or term fees, costumes, uniforms, or other costs. Once invoiced the account is payable under the terms set out on the invoice regardless of the completion of term tuition or performance participation, unless agreed in writing by UNITY Dance Co's Principal.
6. Costumes and any other items ordered or provided by UNITY Dance Co will be invoiced with payment required before items are released to students.
7. Students under the age of 18 are not to leave UNITY Dance Co premises, events, competitions, or performances, unless accompanied by a parent or guardian or written permission is given.
8. All items produced by UNITY Dance Co (including original music edits, choreography, creative concepts, costumes, props, and sets) remain the property of UNITY Dance Co and may not be replicated or reproduced without written permission of UNITY Dance Co.
9. Students of UNITY Dance Co that are part of the competition team dance only within the company unless agreed upon by Unity Dance co Principal (please obtain written permission to attend courses, auditions, performances and workshops)
10. Students are dancing at their own risk, if medical attention is required parents or guardians will be notified, all medical costs is the parent/guardian or student if over the age of 18 responsibility.
11. It is the responsibility of parents or guardians (of students under the age of 18) or students (over the age of 18) to provide current medical information to UNITY Dance Co.
12. To provide adequate dance training, it is necessary for UNITY Dance Co teachers to physically coach in the development of student technique and placement, which may require strictly appropriate physical contact between UNITY Dance Co teachers and students.
13. All students are invited to participate in UNITY Dance Co's mid-year showcase and end of year concert as long as they have attended adequate classes to do so.
14. Students are invited to participate in UNITY Dance Co events, competitions, or performances at the discretion of the UNITY Dance Co Principal. Student invitations will be made based on several factors including and not restricted to, technical strength, attendance, consistent development, commitment to classes and personal progress and rehearsal availability. These events involve costs such as costumes, props, choreographer fees and competition entry fees. These additional costs will be invoiced and are payable in addition to UNITY Dance Co term or tuition fees.
15. Students participating in competition classes are expected to represent UNITY Dance Co in events, competitions and performances and are expected to have a 90% attendance rate to all classes and rehearsals, they must attend Progressing Ballet Technique (PBT) class once per week. Students are required to wear full studio uniform to, from and during all events, competitions, or performances.
16. Dance Co event, competition, or performance, when agreeing to participate have also provided consent for UNITY Dance Co to use Parents or guardians of students under 18 years of age, and students over 18, who agree for a student to participate in a UNITY photographs and/or video footage of the dance student for promotional purposes. For example, use on websites, social media, newspapers, events, or flyers.
17. UNITY Dance Co are not responsible for any property lost or damaged at UNITY Dance Co premises, or UNITY Dance Co events, competitions, or performances.
18. All students enrolled in Contemporary classes are expected to attend at least one Ballet or PBT class per week.
19. All students enrolled in Acrobatics classes are expected to attend at least one Jazz, Ballet, Hip Hop or PBT class per week.
20. All parents, guardians, and students over the age of 18 are responsible for remaining up to date with UNITY Dance Co information, policies, and schedules. This information may be provided by email, posted on social media, and posted on the UNITY Dance Co website – unitydanceco.com.au.
21. Internet and social media posts directly related or involving UNITY Dance Co must be respectful and in line with the ethos and culture of UNITY Dance Co. UNITY Dance Co choreography may not be posted on the internet or social media without permission from UNITY Dance Co's Principal.
22. UNITY Dance Co students and parents are expected to behave in a respectable manner towards UNITY Dance Co teachers, parents, students, students from other dance/performance schools, event, competition and performance staff and members of the public including on social media. Any behaviour deemed disrespectful or damaging to UNITY Dance Co, a teacher, student, or parent, may result in expulsion of the responsible student(s) and parent(s) from UNITY Dance Co classes, events, competitions and performance, and the forfeiture of any outstanding term fees/payments.
